WHO IS BEHIND ORDER SUMO

Order Sumo is a registered company, with registered address at 33 Laird Street, Coatbridge, ML53LW. You can find more information about us on our website – www.ordersumo.com

COLLECTING AND PROCESSING DATA

In order to effectively do business with our customers and partners, we will request personal information: name, business, business address, telephone number, email address, billing address, credit card information.

Data is processed digitally at Order Sumo and is gathered via secure software platforms that are established within our business, and acts as a main service provider. These include third party vendors and hosting partners to provide the necessary hardware, software, networking, storage and related technology required to operate Order Sumo. Although Order Sumo owns the code, databases, and all rights to the Order Sumo application, you retain all rights to your data.

LEGAL BASIS FOR PROCESSING DATA

We actively request consent and permission from our users via pop ups and registration processes on all services provided by Order Sumo. Consent to utilise cookies and personal information is included on all websites and apps produced by Order Sumo.

WHAT DO WE DO WITH YOUR PERSONAL INFORMATION

To utilise Order Sumo services, personal information must be shared with Order Sumo in order to process orders effectively. When you shop or register, we will ask you to submit – and will collect – personal information from you, including: your name, email address, billing address, delivery address, telephone number, product selections, credit card and other payment information, and a password. We, and our third-party providers, may collect information about your internet connection, browser type, IP address, domain type, web page visits and any search terms you entered on the website (User Information). We use this information to help us make improvements to our website and online services.

Any personal information you provide to us (or which is available on public registers) and any User Information from which we identify you is held in accordance with the registration we have with the Information Commissioner's Office. We use your information for the following purposes only:

- To process your order
- For statistical purposes to improve our service offering

- To provide you with relevant content
- To administer this website

Your personal information is not shared with or sold to other organisations for commercial purposes, except to provide products or services specifically requested. Personal Information may be disclosed to other businesses within Order Sumo Partnerships who will help process your order. The Order Sumo Partnership requires all such partners to treat your personal information as confidential and to comply with all applicable UK Data Protection and consumer legislation in place at any given time.

We may disclose your personal information and/or User Information if we are asked to do so by the police or any other regulatory or Government authority investigating suspected illegal activities.

We may disclose your personal information and/or user information if Order Sumo is acquired by or merged with another company. In this event, Order Sumo will notify you before information is transferred and becomes subject to different policy.

Collected data will be retained indefinitely unless otherwise requested.
